- □ Rich began the meeting with a review of last months meeting:
 - Feelers have been sent to the Florida Polytechnic University in the hopes of getting engineering students involved with amateur radio
 - The spring picnic is scheduled for March 15, and will be held at Lake Parker Park
 - The latest band pass filter requested by Fred was purchased and is now in his possession
 - Patrick has volunteered to prepare food for Field Day 2014. He is looking for a large grill for use that day. A budget was approved for the food.
- □ Since the last board meeting, we had the first meeting of 2014. The speaker was Rich Kennedy, who presented the case for inexpensive alternative power supplies for use in amateur radio.
 - One of these power supplies is being used on the Buddy Pole DXpedition.
- Richard Sharp has been in discussion with Yaesu, is promoting a new repeater that functions in either the digital or analog world simultaneously. It is called the Yaesu Fusion. When Richard Sharp learns more, he will present his findings to the club.
 - Mike had some reservations with yet another proprietary format.
- Rich posed the question, "should the club sponsor a tailgate party for all the local clubs?"
 - Fred thought it would be a good ideal, especially for new hams looking for used equipment. There was some discussion about venue.
 - Mathew suggested that towns sometimes allow events like tailgate parties.
 - Bob Sigel thought that a tailgate party would be a good idea.
 - Bill asked Don if the Sun and Fun Grounds might be open for a tailgate party.
 - Don said that he had several contacts that might be helpful in answering this question.
- □ Al gave a progress report on his efforts to get JT65 up and running. Some highlights:
 - Patience required, QSO takes 4 minutes, but on the other hand incredible distances are possible at relatively low power, and less than optimal antennas.
 - Timing is important. Your computer clock must be within a second or two of standard time.

- In just a few hours airtime Al has been able to reach a dozen states, and several countries, including Australia.
- One unique feature of this mode is that the signal strength is generated automatically by the software and reported automatically.
- □ Fred addressed several items:
 - The club was in need of a PR man to replace George Mann. George will train his replacement. Bill will place the job opening on the blog.
 - He was a concern about having enough batteries for field day. It appears that we have sufficient power.
 - There was discussion about battery desulfators. These might be used to keep our batteries in peak condition, and extend their lives. Investigation is required.
 - Opportunity drawings during general meetings and on field day were discussed.
 - The pros and cons of a high-end radio were addressed for the opportunity drawings.
 - It was suggested that the radio could be a one-time door prize some month funded by 50/50 drawings at each meeting.
 - Mike suggested that we ask Yaesu to donate a radio for this purpose.
- □ Rich asked Mathew to run the 50/50 during the meeting. He agreed.
- Bob Foxworth gave the treasure's report. It is attached.
- Don was approved as LARC representative to TARC for next year.
- □ There was brief discussion about discounted membership rates for snowbirds. The board was not in favor.
